

APPENDIX A:

Water Rates and Fees Effective July 1, 2020

Nothing in this Policy shall be construed or interpreted as a contract to provide Water Service.

Adjustments

- 1) The Board of Directors reserves the right to adjust Rates & Fees at any time as needed.

Residential, Commercial & Industrial

- 1) This rate applies to all residential, commercial, governmental, institutional, not-for-profit and industrial Customers.

BASE FEE (No gallons)

¾ Inch Meter:	\$20.00	2 Inch Meter:	\$160.00
1 Inch Meter:	\$50.00	All above 2 Inch:	\$300.00

VOLUMETRIC RATE \$5.90 / 1,000 gallons

Large User

- 1) This rate applies to all Customers using an average of 1,000,000 gallons or more per month over the course of the fiscal year (July 1 – June 30).

BASE FEE (No gallons)

¾ Inch Meter:	\$20.00	2 Inch Meter:	\$160.00
1 Inch Meter:	\$50.00	All above 2 Inch:	\$300.00

VOLUMETRIC RATE \$4.85 / 1,000 gallons

 **Increase to \$5.00**

Fire Hydrants

- 1) NCWSA must grant approval for all water purchased from fire hydrants. **The base fee for a hydrant meter is \$20.00 (no gallons). Usage is billed at the commercial volumetric rate.**

Stand-By Agricultural Rate

- 1) Large agricultural users, whose operations are entirely agricultural in nature, may be granted Stand-By Agricultural Rate Status. The NCWSA Manager must verify that the Customer's operation is purely agricultural in nature.
- 2) This rate shall be ½ the base fee for the size meter installed for all months with zero consumption. Any month water is used shall be billed at the base fee plus the commercial volumetric rate.

Travel Trailer / RV Parks

- 1) Trailer and RV Parks will be charged according to the commercial rate schedule.

Mobile Home Parks

- 1) Rates for Mobile Home Parks established prior to April 28, 2011 will be based on the Commercial Rate Schedule, plus \$4.77 per SCDHEC approved mobile home site.
- 2) Rates for Mobile Home Parks established after April 28, 2011 will be based on the Commercial Rate Schedule with no additional per site charge.

Sewer Rates and Fees Effective July 1, 2020

Residential

- 1) Sewer Service billed on the amount of water metered each month.

BASE FEE (No gallons)

Residential:

\$22.00 → **Increase to \$23.00**

Flat Rate (No Water Service):

\$47.00 → **Increase to \$48.00**

VOLUMETRIC RATE

\$7.00 / 1,000 gallons

Commercial & Industrial

- 1) Sewer Service billed on the amount of water metered each month. Additional pre-treatment charges may apply to Commercial and Industrial Customers.

BASE FEE (No gallons)

Commercial

\$55.00 → **Increase to \$57.00**

Industrial

\$175.00 → **Increase to \$200.00**

VOLUMETRIC RATE

\$7.00 / 1,000 gallons

Large User

- 1) Sewer Service billed on the amount of water metered each month. Additional pre-treatment charges may apply to Large User Customers.

BASE FEE

Assessed on a case by case basis

VOLUMETRIC RATE:

\$7.00 / 1,000 gallon

- 2) The base fee for these Large User Customers will be assessed based on flow minimums. Large User Flow Minimums (gallons):

- Town of Prosperity 3,070,000
- Pioneer Frozen Foods 500,000
- Georgia Pacific 608,100
- McKechnie Vehicle Components 650,000
- SCDOT (I-26 Rest Area) 225,000
