Separate sealed bids for the Hollands Landing Road Pump Station will be received by Owner in its office at 13903 C. R. Koon Highway, Newberry, South Carolina until 2:00 P.M. Tuesday, May 13, 2025 and then at said place be publicly opened and read aloud.

The work to be done consists of furnishing all materials, equipment and labor necessary to construct a replacement for an existing duplex submersible wastewater pump station and related work. Also, demolition and removal of the existing pump station once the new station is in operation.

This project is being funded in in part by a grant from the SC Rural Infrastructure Authority (SCRIA).

Neither the Owner nor the Engineer will be responsible for the accuracy or completeness of Bidding Documents, including Addenda (if any), obtained from other sources. Bidders must be on the Engineer's official plan holders list for bids to be accepted by the Owner.

Bidders must deposit security with all bids. Security shall be in the form of a certified check or bid bond made payable to the Owner and shall be for an amount equal to not less than five percent of the amount of the bid. Provisions of the security shall be as described in the Information for Bidders.

No bid will be considered unless the bidder is legally qualified under the provisions of the South Carolina Contractor's Licensing Law (South Carolina Code of Laws as amended on April 1, 1999, Chapter 11, Sections 40-11-10 through 40-11-428).

Contractors shall have a classification of WL.

No bidder may withdraw the bid within ninety days after the actual date of the opening and thereof.

The Owner reserves the right to waive any informalities or to reject any or all bids.
