### **I. PROJECT OVERVIEW**

Newberry County Water and Sewer Authority (NCWSA) is requesting sealed bids from qualified contractors for the replacement and/or repair of three culverts located on public rights-of-way. Culverts were damaged during Hurricane Helene. This work is associated with a FEMA Public Assistance (PA) claim and must comply with all applicable federal procurement requirements under 2 CFR Part 200.

The awarded contractor will be responsible for furnishing all labor, materials, equipment, transportation, supervision, and incidentals necessary to perform the work in accordance with the project specifications.

### **II. SCHEDULE**

The awarded contractor will be responsible for performing the work in accordance with the project specifications within 120 days of the notice to proceed.

### III. SCOPE OF THE WORK

All disturbed areas must be returned to pre-disaster conditions or better, and any vegetative debris or waste materials must be legally disposed of.

#### Site 1 – Mid Carolina Commerce Park Culvert

**Location:** 1800 SC-773, Pomaria, SC 29126 (34.24400, -81.47800)

**Conditions:** The original culvert was destroyed and no longer exists. Access via private gravel road in rear of Mid Carolina Commerce Park and unimproved utility right-of-way to site.

**Work includes:**

- Excavation of the failed site
- Installation of a new culvert to original dimensions
  - 60-inch diameter (x 20-ft) galvanized steel culvert or equivalent
- Installation and compaction of red clay fill dirt
- 12-ft wide minimum small surge stone roadway surface on culvert and 20-ft long approach aprons
- Installation of new geotextile and Class B rip rap around inlet, outlet, and embankment - Rip rap shall fully cover each end wall
- Erosion control measures
- Site stabilization and restoration as required

#### Site 2 – Oxner Road Pump Station Culvert

**Location:** 2300 Oxner Rd., Newberry, SC 29108 (34.29000, -81.53800)

**Conditions:** Culvert is present and functional. Damage to end treatments and surrounding embankments. Access via private gravel road from Oxner Road to site.

**Work includes:**

- Removal and/or replacement of damaged end treatments
- Installation and compaction of red clay fill
- Installation of new geotextile and Class B rip rap around inlet, outlet, and embankment - Rip rap shall fully cover each end wall
- 12-ft wide minimum small surge stone roadway surface on culvert and 20-ft long approach aprons
- Erosion control measures
- Site stabilization and restoration as required

#### Site 3 – SC Hwy 219 at Dusty Road Culvert

**Location:** 5805 SC-219, Newberry, SC 29108 (34.29500, -81.54500)

**Conditions:** The culvert is present and functional. Damage to end treatments and surrounding embankments. Access from Dusty Road via unimproved utility right-of-way to site.

**Work includes:**

- Removal and/or replacement of damaged end treatments
- Installation and compaction of red clay fill



- Installation of new geotextile and Class B rip rap around inlet, outlet, and embankment - Rip rap shall fully cover each end wall
- 12-ft wide minimum small surge stone roadway surface on culvert and 20-ft long approach aprons
- Erosion control measures
- Site stabilization and restoration as required

#### **IV. BID REQUIREMENTS**

Bidders must submit the following:

- Completed bid schedule with lump sum pricing
- Work schedule and anticipated time for completion
- Proof of applicable licenses and insurance
- References for similar completed projects

#### **V. FEDERAL PROCUREMENT REQUIREMENTS**

This project is funded under the FEMA Public Assistance program. Contractors must not be suspended or debarred from receiving federal funds and must follow:

- 2 CFR Part 200 – Uniform Administrative Requirements
- FEMA Contract Provisions (Appendix II to Part 200)
- Equal Employment Opportunity (EO 11246)
- Davis-Bacon Act (if applicable)
- Copeland Anti-Kickback Act
- Byrd Anti-Lobbying Amendment
- Contract Work Hours and Safety Standards Act

#### **VII. EVALUATION CRITERIA**

Bids will be reviewed and awarded based on:

- Relevant contractor experience (35%)
- Cost competitiveness (25%)
- Compliance with bid requirements and FEMA regulations (20%)
- Ability to meet schedule (20%)

NCWSA reserves the right to reject any or all bids.



## VIII. COST PROPOSAL

**Note:** All lump sum prices must be inclusive of all labor, materials, equipment, mobilization, site preparation, traffic control, and any other costs necessary to complete the scope of work described. Pricing must reflect a complete, turn-key project cost for each culvert site.
